The 2023/24 period marked an inspiring resurgence for AOC and the opera sector, with significant milestones in our national and international impact. Aligned with our Strategic Plan, AOC strengthened its global connections by leading a Canadian delegation to Opera Europa in Copenhagen in October. This mission advanced our goal of international collaboration, sharing Canadian innovation on the world stage.

The momentum continued as we gathered in Winnipeg in November for the annual Opera Summit Embracing Challenges, Unlocking Opportunities and the new production Li Keur. The Summit drew an impressive turnout to discuss strategies to re-vitalize the art form, develop next generation leadership, and balance opera's civic impact with organizational realities.

As part of our work to secure sustainable funding for opera, AOC joined SI Canada to explore social finance with the innovative concept of Opera Bonds. In January 2024, we proudly presented the Canadian New Works Showcase in New York as part of the New Works Showcase. This celebration of Canadian talent highlighted groundbreaking works by Canadian artists for new audiences and exemplified our dedication to elevating Canadian stories and artistic voices.

The year concluded with Canada's presence at the World Opera Forum in Los Angeles, where global opera leaders engaged in pivotal conversations about the future of the art form.

Our heartfelt thanks go to our staff and board members, whose efforts made these accomplishments possible. Together, we continue to build a future where opera thrives as a dynamic and accessible art form.

FINANCIAL REPORT

Overview

Thank you to the audit committee for reviewing the statements, Debra King, Edmonton Opera, and Saptarsi Saha, COC.

The 2023/24 AOC auditor's report is unqualified.

Our budget in 2024 contracted to a more "typical" budget size of around \$400,000, down from a high of \$1M the previous year due to the large \$584,550K grant in CPAWRF funding to support the Opera Artist Resilience Program.

Overall, the association had a small operating surplus of \$3,333, and with an increase in market value of investments, our overall surplus position at year end is \$6,710.

We proudly acknowledge that this is our 8th consecutive year of operating surpluses, a positive indicator of our financial stability, contributing to our strong net asset position over many year. I congratulate Christina for her strong budgeting and financial oversight assisted by Young Associates bookkeeping services.

WINNIPEG SUMMIT

Returning to Winnipeg, Manitoba for the first time since 2007 with an annual gathering, The Opera Summit Winnipeg, was held November 20-22, 2023, co-hosted by Manitoba Opera. Held jointly at the Canadian Museum for Human Rights and the Fort Garry Hotel, sessions included "Revitalizing the Art Form through the Wisdom of the Room, designed and led by David B. Devan, a keynote address by former Senator Patricia Bovey, as well as panels and consultations on Succession/Leadership Development and Social/Alternative Financing.



COPENHAGEN DELEGATION

As part of our International Market Development Strategy, we hosted <u>an official delegation</u> to the Opera Europa Autumn Conference in Copenhagen/Malmö, October 4th to 7th, 2023. This selected delegation was chosen to represent a Canadian brand that included 9 representatives active in large and small scale coproducing, creators of new and exciting works, Indigenous artists, technological innovators, and civic impact leaders. Kicking off with a networking event the morning of October 4, at the Royal Danish Opera, the delegation was present throughout the conference and featured in various pitch presentations as well.

OPERA BONDS - EXPLORATION

Through a Canada Council for the Arts Seed Grant, AOC has partnered with Social Innovation Canada in exploring the feasibility of a bond offering to investors to develop a pool of capital to create a new Change Fund, providing low interest, repayable capital to the opera sector for projects that generate a social and financial return. We held an in-person consultation at the Opera Summit in Winnipeg and a virtual consultation on February 29 by zoom.

NEW WORKS SHOWCASE - NEW YORK

As part of our International Market Development Strategy, we were delighted to be invited to produce an all-Canadian Showcase recently at the New Works Forum in January. Featured works included those by Julia Dawson – Obscura Nox, Mathilde Côté – La nuit est ma femme, re:Naissance Opera – Eurydice Fragments & Inferno: A Hip Hop Opera, and Soundstreams – Garden of Vanished Pleasures.
